

**HYDROLOGY PROJECT PHASE-II

1. This Request for Expression of Interest follows the General Procurement Notice for this project that appeared in Development Business on July 24, 2004.

The Government of India has received a Loan bearing Loan Number 4749-IN from the International Bank for Reconstruction and Development (IBRD) towards the cost of Hydrology Project Phase-II and the Government of Punjab intends to apply a part of the proceeds of this loan to cover eligible payments under the contract for the Consultancy Services pertaining to the Architectural & Engineering Services for design and construction of the State Data Centre (Water Resources Bhawan) to be constructed by Water Resources & Environment Directorate at Sector-68, SAS Nagar, Mohali, Chandigarh, (Punjab). The objective of this consultancy is to equip Water Resources Organization with well-planned, centrally air conditioned, solar paneled sustainable Green Building for State Data Centre by using innovative energy saving & environment friendly technologies for securing the highest rating as per GRIHA (MOEF) rating systems of Green Buildings and BEE (MOE).
