II The Terms of Reference of the Expert Group on Ground Water Management will be:-

- 1. To determine the characteristics of underground water and aquifers in Punjab With the use of Modern Technologies such as Remote Sensing Satellite Imagery Hydro-Morphology and Sonographs etc.
- 2. To study changes in the ground water profile of the State and to build a forecast of expected changes in the ground water profile of the State.
- 3. To prepare and analyse data at the local level (block level) regarding various aspects of ground water availability and quality.
- 4. To recommend measures for better management of ground water resources of the State

- To finalize an action plan for ground water management of the State and indicate 5. the requirements of institutional reform and financial resources
- The Expert Group will be housed in the Department of Irrigation, Govt of Punjab III. which shall nominate a Nodal officer for the same.
- The Group may device its own procedure and may co-opt any other official/non-IV. official members as required.
- TA/DA for non-official members shall be paid by the Department of Irrigation as V per application norms. As regards official/Govt. Members their TA/DA would be paid by their respective employer
- The Expert Group will submit its report, including the action plan for Ground VI. Water Management of the State, to Government of Punjab by 31st December, 2012.
