Notification

No. 6/19/2011-PJ4/3025.—Whereas it appears to the Governor of Punjab that land is likely to be required to be taken by Government at public expenses, for a public purpose, namely, Additional Land to be acquired for construction of canal syphon at RD 80.400 Km of Kandi Canal Stage-II, village Bhulewal Rathan, H.B. No. 29, tehsil Garshankar, district Hoshiarpur.

It is hereby notified that land in the locality described below is likely to be acquired for above purpose.

This notification is made under the provisions of Section 4 of the Land Acquisition Act, 1894 to all whom it may concern.

In exercise of the powers conferred by the aforesaid section, the Governor of Punjab is pleased to authorise the officers for the time being engaged in the undertaking with their servants and workmen, to enter upon and survey any land in the locality and to do all other acts required or permitted by that section.

Further, in exercise of the power under the said Act, the Governor of Punjab is pleased to direct that action under Section 17(i) shall be taken in this case on ground of urgency provisions of Section 5(a) will not apply in regard to the acquisition of said land. The land in question is waste or arable, as Kandi Canal Extension from Hoshiarpur to Balachaur is being financed by Government of India under Central Loan Assistance through A.I.B.P. Scheme, which is to be completed within scheduled period to provide Irrigation facility to Barani area of Kandi Tract of Hoshiarpur and Nawanshehar District.
