Notification

No. 6/16/2010-PJ(4)/1582.—Whereas it appears to the Governor of Punjab that land is likely to be required to be taken by the Government, at public expenses, for a public purpose, namely land to be acquired for constructing Mehngarwal Distributary from RD kilometer 4.360 to RD kilometer 8.053 off taking at RD 88.731/R kilometer of Kandi canal Stage-II in Tehsil Garhshankar, District Hoshiarpur.

It is hereby notified that land in the locality described below is likely to be acquired for above purpose.

This notification is made under the provision of section 4 of the Land Acquisition Act, 1894 to all whom it may concern.

In exercise of the power conferred by the aforesaid Section, the Governor of Punjab is pleased to authorise the officers for the time being engaged in the undertaking with their servants and workmen, to enter upon and survey any land in the locality and do all other acts required or permitted by that section.

Further in exercise of the power under the said Act, the Governor of Punjab is pleased to direct that action under Section 17(i) shall be taken in this case on grounds of urgency and provision of section 5(a) will not apply in regard to the acquisition of said land. The land in question is waste or arable, as Kandi canal Extension from Hoshiarpur to Balachaur is being financed by Government of India under A.I.B.P. scheme, which is to be completed within scheduled period to provide Irrigation facilities to Barani area of Kandi Tract of Hoshiarpur and Nawanshahar Districts.
